



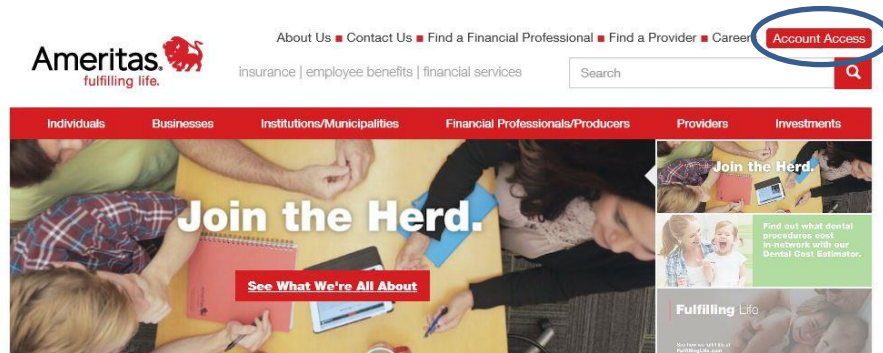

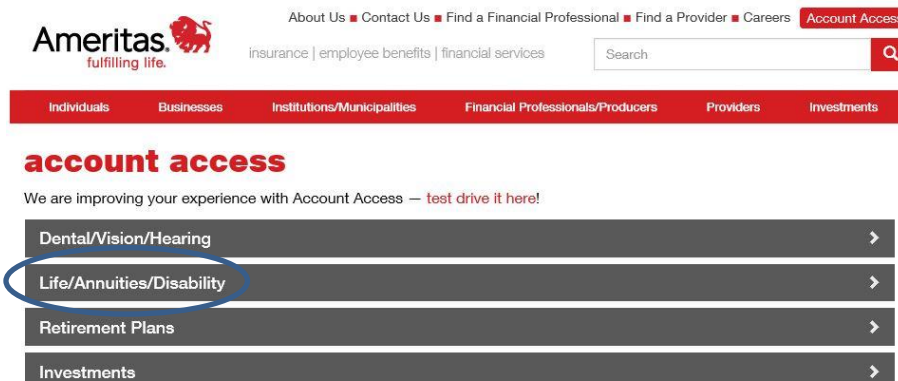
1. Go to www.ameritas.com and click on **Account Access** in the upper right-hand corner.
