

1. Go to www.ameritas.com and click on Account Access in the upper right-hand corner.




2. Click on Life/Annuities/Disability.



4. Click on **Register now** to the right of the User ID field.




5. Choose Client.



7. Complete the Registration form and click **Accept.**



You will receive a registration confirmation and then be prompted to log in with your newly created User ID and Password. For added security, the first time you log in, you will be prompted to complete a 2-Step Verification process:

- **1. Enter a one-time passcode**. You can choose to receive your passcode via mobile phone, e-mail address, or home phone and can click **Remember this Device** if you don't want to be prompted again.
- 2. Choose either to set up an additional verification method or go to your account.
